In consideration of allowing me to take part in this event, I, _____, the undersigned, hereby waive, release, discharge any and all claims for damages for death, personal injury or property damage which I may have, or which may hereafter accrue to me, as a result of my participation in this event. This release is intended to discharge in advance The Meadowview Mountain Goats Mountainbike Club, it’s organizers, sponsors, volunteers and any other person, entity or organization involved in this event (and their respective agents, representatives and employees) from and against any and all liability arising out of or connected in any way with my participation in said event, even though that liability may arise out of negligence or carelessness on the part of the persons, organizations or entities mentioned above.

I acknowledge that cycling is an inherently dangerous sport and fully realize the dangers of participating in a bicycle race and/or organized ride and FULLY ASSUME THE RISKS ASSOCIATED WITH SUCH PARTICIPATION INCLUDING, by way of example, and not limitation, the following: the dangers of collision with pedestrians, vehicles, other racers or riders, and fixed or moving objects arising from surface hazards, equipment failure, inadequate safety equipment, THE RELEASEE’S OWN NEGLIGENCE, and weather conditions; and the possibility of serious physical and/or mental trauma or injury associated with athletic cycling competition and recreation.

I understand that it is not recommended by The MVMG or any organizers, sponsors, volunteers or any other person, entity or organization involved in this event that participants venture on to private land. This event offers participants the opportunity to acquire ‘game chips and geo-cache tokens’ that are placed in locations that are of public access and not limited by law or ownership to enter. It is recommended that routes taken to acquire these ‘game chips and geo-cache tokens’ also be on land of public access and not limited by law or ownership to enter. Any trespassing or legal infraction that takes place involving a participant/releasee in this event is the sole responsibility of that participant/releasee, and is considered THE RELEASEE’S OWN NEGLIGENCE. I FULLY ASSUME THE RISKS ASSOCIATED WITH SUCH PARTICIPATION.

I agree it is my sole responsibility to be familiar with the event’s pertinent locations, the Releasee’s rules, and any special regulations for the event. I understand and agree that situations may arise during the race and/or organized ride which may be beyond the immediate control of the race officials or organizers, and I must continually ride so as to neither endanger myself nor others. I accept responsibility for the condition and adequacy of my cycling equipment. I have no physical or medical condition which to my knowledge, would endanger myself or others if I participate in this event, or would interfere with my ability to participate in this event.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
